Project Goals & Impact*

Using the following scale, rate the efficacy of the project goals and impact they will have on the organization as described in the application.

0=Project goals are unclear, no way to measure impact they will have on the organization or its capacity to better deliver humanities programming after completion.

5=Goals articulated, but some questions remain about specific deliverables or impact.

10=Project goals are clear; plan is solid; project has high likelihood of having a positive impact on organization and its operations.

Scoring Options: 0 - 10

Support for the Humanities*

Using the following scale, rate the applicant's current and future ability to deliver humanities content and programming to the public:

0=The organization does not currently deliver strong humanities content or programming to the public and capacity building project unlikely to help organization to do so in the future.

3=Organization currently delivers strong humanities content or programming to the public, but unclear if capacity building project will substantially help organization increase its capacity to do so after completion.

5=Project likely to substantially help the organization increase its capacity to deliver humanities content and programming to the public in the future.

Scoring Options: 0 - 5

Project Schedule*

Using the following scale, rate the proposal's project schedule:

0=Project activities occur outside of the grant period or the project schedule is inappropriate for the capacity project.

3=Project schedule is adequate; some minor concerns with the schedule may exist.

5=Project schedule is well thought out, articulated, achievable, and likely to lead to a successful final product.
