Restoration of the CT Cultural Fund would continue to catalyze growth by expanding cultural opportunities for Connecticut's residents and communities.

Studies also show that students engaged in arts programs perform better academically, exhibit higher levels of creativity, and develop essential problem-solving skills ... ensuring our future workforce is equipped with the well-rounded skills they need to excel in a rapidly changing world."

ECONOMIC IMPACT

"Our outreach will be reduced, which affects ticket sales. There had definitely been an economic impact to CT businesses as we increased the number of shows and attendance: Increased dining in local restaurants before/after the shows, printed programs, and increased consumption of materials for set building."

REDUCED MARKETING, THUS REDUCING AUDIENCE AND EARNED INCOME

"Reduced ability to publicize our performing and visual arts events, resulting in reduced attendance."

HARDER TO BUILD CAPACITY

"It will be difficult for us to continue paying for the monthly bill for our upgrade in internet speed, to finish purchasing new computers, and pay for our IT service."

"We anticipate delays in property maintenance initiatives due to reduction in funding."


